Since being announced in the Beam, 31 members have signed up for the Nantucket/Martha's Vineyard trip. The trip will include all meals, at least one boat trip and three nights lodging at the Lighthouse Inn in Dennis, MA. The trip will leave the weekend after Memorial Day. Deposits are due to Betty no later than January 10<sup>th</sup>. To date 19 members have signed up for the Long Island Lighthouse Challenge bus trip.

- "Thank You" to everyone involved with the planning and production of the 2007 Challenge. It was an Overwhelming Success!
- Highlights include
  - o 39% more people started than in 2006
  - o 51% more people finished than in 2006
  - o 76% of Starters actually finished (up from 70% in 2006)
  - o 2,000+ volunteer hours logged on Challenge weekend
  - o 148 completed the Dual Challenge (32% of total MD finishers)
  - o 65 completed the Triple Challenge (30% of total LI finishers)
