**Call to Order**

President Mary Beth Doherty called the meeting to order at 10:05 AM and led the membership in the Pledge of Allegiance. The fire safety briefing was provided by a member of the Liberty State Park staff.

**Minutes from March 20, 2010 General Meeting**

Bob Gleason submitted the minutes from the March 20th meeting at Tuckerton Seaport. There being no changes noted, Tom Laverty made a motion to accept the minutes. Mike Boucher seconded the motion and it was passed unanimously.

**President's Opening Remarks:** Mary Beth acknowledged new member Jaelyn Jablow and her father, Ray and thanked them for their generous donation of some coffee, donuts & bagels for today's meeting.

**Review of the Day's Agenda:** Cindy Mitzen explained the schedule for the day's events. Following the business meeting, the attendees will split into two groups. One group will accompany the State Park Guide and tour the train terminal while the second group will remain in the Blue Comet Room and watch the Liberty State Park video history. After thirty minutes the two groups will exchange roles. At noon, the group will break for lunch. Cindy encouraged anyone who did not bring their own lunch to please patronize the State Park's concession stand. By 12:45 PM everyone should be in the screening line for the Liberty Island ferry which has a 1:15 PM departure. Members were reminded to pick up their ferry tickets at the membership table.

The Ludlum Beach Group is soliciting other towns and Cold Springs about taking the light but nothing is looking good. Money is the issue and September is now the deadline since the current lighthouse owner has finally received his clearance to build a new residence on the property.

**Special Recognition for Mike Boucher** – As NJLHS representative to the NJ League of Historic Societies, Cindy presented Mike, as editor of THE BEAM, with the League’s FIRST PRIZE Award for Distinguished Journal. All in attendance stood and gave Mike a warm round of applause.

### Trips – Apryl Roach

- Aug 7-8 Lighthouse Lovers Getaway Weekend is a go. The actual ferry trip to the lighthouse will run from 6-10pm on Saturday, August 7<sup>th</sup>.
- Oct 2 – Long Island Sound, Western Connecticut Lighthouse Cruise is still tentative pending more people signing up.
- Oct 23-31 Southern East Coast Lighthouse Tour (NC, SC, and GA) is about 50% subscribed so the cut-off date for deposits has been extended to July 30<sup>th</sup>. If the required minimum number is not reached, this tour will be rescheduled for 2011.

**Community Outreach & Publicity** – No Report since Anthony Albence was delayed by traffic. Mary Beth asked everyone to “Friend” and “Tweet” NJLHS in Facebook and Twitter.

### Education Outreach / Speakers Bureau – Bob Gleason

- There were five different 2nd Quarter speaking activities bringing the total number of attendees up to 246 YTD (169 students, 77 adults).
- Highlights included:
  - Faith Giamboi & Bob Gleason’s meeting with 120 second graders at Cedar Creek Elementary School in Lacy Township. The entire grade level had completed very accurate lighthouse projects made from recycled materials.
  - Bill Volpe’s presenting to Our Lady of Lourdes 4<sup>th</sup> graders in Milltown. Bill received a priceless thank-you note from one of the students. “The stories about famous lighthouse women were good. They showed the boys that women were just as good as men.”
