### **President's Call to Order**

President Mary Beth Doherty called the meeting to order at 11:03 AM and led the membership in the Pledge of Allegiance. The fire safety briefing was provided by Jim Cope. Mary Beth mentioned that this would be her last meeting as NJLHS President but noted that she looked forward to continuing to serve as a member of the Board of Directors. Mary Beth acknowledged the efforts of Cindy Mitzen and many others as a furnace failure at the Sandy Hook Chapel forced the meeting to be moved to Twin Lights at the very last minute. The patience, understanding and good humor of the membership as we moved to our new site was appreciated.

### **Minutes from Prior General Meetings**

Bob Gleason submitted the minutes from the June 26th meeting at Liberty State Park. There being no changes noted, Tom Laverty made a motion to accept the minutes. Anthony Albence seconded the motion and it was passed unanimously. Bob then submitted the minutes for the September 25th meeting in Lewes, Delaware. Since Bob was not able to attend the September meeting, the Lewes minutes were prepared by Karen Stumpf-Owen, the 2011 nominee for Recording Secretary.
